## 1. Co-Chairperson's address (by Nóirín Mulvihill)

Nóirín welcomed the attendees to the fifth AGM of the Mary Mulvihill Association and the first one online. She reflected on the past year and began by reminding the attendees why they were here. She shared that the association was set up five years ago when a group of Mary's friends and colleagues, saw to remember Mary in the best possible way, by reflecting her work. So initially some of aims seemed very ambitious from reprinting Ingenious Ireland to collating and finding a suitable home for her archive. Nóirín expressed that she believed Mary would be overwhelmed and honoured by what has been achieved so far and the hard work and support of all involved.

She noted that a number of the main objectives of the association were achieved in the previous year and the relevant sub-committees were wound down – The archive was moved to DCU and with the financial support from DCU, Dublin Port and Dias, and the hard work of our previous chair Margaret Kelleher, Ingenious Ireland was reprinted in October 2019 in conjunction with Four Courts Press. Nóirín also mentioned that the launch at EPIC was a wonderful event and one that we are all glad to have been part of.

She continued by thanking Patrick and David Green, the Directors of Epic, for their generous support, and noted that, with thanks to DIAS, there is now a copy of the book in every county library in the country. Both projects honoured Mary and her work.

She then brought up the Mary Mulvihill Award, which was first set up in 2015. She thanked both Cormac Sheridan and Brian Trench for there hard work from the beginning and the judges, both past and present, for their time and expertise.

She thanked the previous Officers, Margaret Kelleher, Anne Fitzgerald, and Ena Prosser for their trojan work which laid a solid foundation from which to build. She singled out Ann and Margaret particular for their guidance to herself and Therese during the past year. She thanked the other members of the committee for their hard work throughout the year.

### She paid tribute to Ena Prosser, who stepped down as treasurer at the AGM

"Her vision and dedication have never wavered. Her support has been constant, her knowledge of the Governing Instrument invaluable. But above all, she has done this with a willing heart and has never forgotten her friendship with Mary. I know she thinks of her fondly as she views the diving well from her office window. Ena, we owe you a great debt of gratitude for all this hard work."

She concluded by noting the remaining committee had big boots to fill.

Therese Caherty thanked Nóirín for her address and stated that it was very moving and agreed that it was important to look at where the association started and came from. She said that we were inclined to forget where we come from at times. And it was important to be reminded of what has already been achieved

#### 5. Secretary's Report including reports from sub-groups

The Secretary's Report, which had been circulated in advance of the meeting, was taken as read and adopted.

Fionnuala mentioned that there had been progress in commissioning a plaque in Mary's honour and thanked Rebecca O'Neill and Brian Dolan for their work on that. She also noted that there were a number of committee members who had been on the committee since the beginning and will be stepping down at the 2021 AGM.

She thanked the committee for their assistance in the course of her first year as Secretary. She also thanked the members of the sub-committees for their hard work during a turbulent year.

### 6. Treasurer's Report and Accounts for year ended 31 August 2020 (to be tabled)

Ena invited attention to her Treasurer's Report and Accounts for year ended 30 August 2020 which had been tabled.

She started by noting the financial year is the end of the financial year is the 30<sup>th</sup>, August of every year. And as such there is always a lag between the end of the financial year and the AGM. The Treasurer's report runs from August to August.

We have two bank accounts. A business banking account, which is important if we're doing any vendor qualification - this is the anti-money laundering element of the organisation. When we book venues such as Epic, they require that we have these, this level of governance now from an anti-money laundering perspective. While they're expensive and administratively a bit more complex, they are necessary.

She noted that, in preparing the accounts, professional financial and legal advice had been provided by Quaestor Management Services Ltd and Alice Murphy from Mason Hayes Curran respectively. Ena advised that the Association's Auditor, Sarah-Jane Larkin of Quaestor Management Services Ltd. had audited and signed the accounts in accordance with the requirements of the Institute of Chartered Accountants of Ireland. The meeting noted that the auditing fee for this work was €100 + VAT for which the meeting expressed its appreciation.

She noted that our income was down for the year ending 30<sup>th</sup>, August 2020. This was a reflection of the previous year's higher income. In addition, the organisation had more expenses including the republication of Ingenious Ireland. There was one anonymous donation of €50 which could not be traced to a membership application. She stated that there is a provision for the Plaque project in 2021. The Ingenious reprint invoice

received was for €4,000 and has been paid. There were significant banking charges and some legal fees (~€600) as a result of changing the governing instruments.

She stated that the Closing Balance was  $\in$  32 121.34, which included a substantial donation of  $\in$  1,400 from the royalties on Ingenious Ireland, which was donated by Mary's nephew, Oren and a further  $\in$  5,000 donated by Brian Dolan. There is a small balance on the working account of the organisation of around  $\in$  441.

The committee expressed their appreciation for the generous donation from Oren and Brian.
